

# Garage Privacy Policy

Garage.XYZ, Inc, (“Garage,” “we,” “us,” or “our”) knows that privacy is very important to you.

In this Privacy Policy (the “Privacy Policy”), we describe what kinds of personal information we may obtain online through your use of our website, located at <https://mygarage.xyz>, the services provided through the website, and when you interact with us in other ways (all of the above collectively referred to as the “Garage Services,” or “Services”). By visiting <https://mygarage.xyz> or using the Garage Services, you accept the practices described in this Privacy Policy.

## 1. What this Privacy Policy Covers

This Privacy Policy covers how we treat Personal Data that we gather when you access or use our Services. “Personal Data” means any information that identifies or makes identifiable a particular individual. This Privacy Policy also includes information referred to as “personally identifiable information” or “personal information” under applicable data privacy laws, rules or regulations. We will refer to the personal information we obtain about you as “Your Data.” We explain the steps we take to keep Your Data secure, your choices regarding our use of this information, and how you can contact us if you have any questions about our privacy practices.

Our Services may contain links to third-party websites (“External Sites”). We have no control over the privacy practices or the content of any such External Sites. As such, we are not responsible for their content, use or privacy practices. We strongly suggest that you review the applicable privacy policies and terms of service when visiting any External Sites.

We offer our Services with the help of the vendors listed below. They will treat Your Data according to their own privacy policies, over which we have no control.

- Our community is hosted on Discord (<https://discord.com/>), and you cannot join us without joining Discord. For information about Discord’s privacy practices, please visit <https://discord.com/privacy>.
- We use SendGrid for our email communication. Its privacy policy is located at <https://www.twilio.com/legal/privacy>.
- If you purchase a membership token through our website, any financial transactions involving you will be conducted solely through the Ethereum network. By using Ethereum’s services, you accept its terms of service and its privacy policy, which can be found at: <https://ethereum.org/en/>.

## 2. Information We Collect

### a) Information you provide to us

We collect information you provide to us when you use our Services or otherwise communicate with us. This may include the following kinds of personal information:

- your discord handle;
- your wallet address;
- your email address; and
- information contained in the content of communications you send to us when using our services.

### b) Information we collect automatically

Like most online services, we automatically receive standard technical information when you connect with the Services. We collect this information through browser cookies, flash cookies, pixels, web server logs, web beacons, and similar technologies. These features enable us to personalize your experience with our Services, understand how you use them, maintain a

persistent session, and improve and further develop the Services. Information we collect automatically includes or could include:

- browser and device information such as unique device identifiers, mobile phone carrier, internet protocol (IP) addresses (which may identify your general geographic location), user agent string (e.g., operating system and browser type/version), and the date and time of your interactions;
- information about your interactions with the Garage Services, such as which pages of our website you visited, how much time was spent on the page, and whether you bread the emails and text messages we sent to you; and
- geolocation information.

### c) **Information collected through third-party analytics services**

We use third-party web analytics services to evaluate your use of the Garage Services and to help us improve our performance and to develop new products, services, features, and functionalities. The third-party analytics services collect and analyze information about your online activities on your electronic devices, the Garage website, third-party websites, apps, and other online services. The third-party analytics services we use for these purposes is Google Analytics, but we may use other services in the future.

Please be advised that if you opt out of any service, you may not be able to use the full functionality of the Garage Services.

## 3. **How We Use Your Data**

We use Your Data to provide the Services to you and to operate our business. This includes:

- Service-Related Usage: We use the information we collect from and about you to provide and support the our Services, such as communicating with you and other users, managing user accounts, providing customer service, and maintaining our systems.
- Analyzing and Improving the Garage Services: We may run calculations, aggregate, normalize, anonymize, clean, and make derivative works of Your Data in order to:
  - understand and analyze usage trends and preferences;
  - monitor and analyze the effectiveness of our Services;
  - improve the Services and develop new products, services, features, and functionality; and
  - test the Services and our infrastructure to make sure the Services are working correctly.
- Marketing: As permitted by applicable law, we may use Your Data for marketing purposes, such as providing you with promotional materials that could be useful,

relevant, valuable, or otherwise of interest to you. Where required under applicable law, we will obtain your prior opt-in consent to send you electronic marketing communications or text messages.

#### **4. How We Share Your Data**

We share, transfer, or disclose Your Data if you consent to us doing so, as well as in the following circumstances:

- Service Providers: We share information with third parties who provide services to us, such as customer services, website management, information technology and IT security, auditing, payment processing, data analytics, advertising, marketing, and other similar service providers. We do not authorize these service providers to use or disclose Your Data except as necessary to perform services for us or to comply with legal requirements.
- Other Users of the Services: When you interact with other Garage users, either directly or in the public areas of our Services, they will be able to: view your Discord handle, your profile picture, other Discord servers you have joined, and other information you have stored in your Discord profile; and communicate with you.
- Compliance with Legal Requirements: We may disclose Your Data if required or permitted to do so to:
  - comply with applicable laws and legal processes;
  - respond to requests from law enforcement authorities, public and government agencies or officials, or other persons or entities with appropriate legal authority or justification to receive such information, including persons or entities outside your country of residence; and
  - protect our rights, privacy, safety, or property, and / or that of our affiliates, you, or others.
- Affiliates and Successors: We may share some or all of Your Data with any of our parent companies, subsidiaries, joint ventures, or other companies under common control with us. Further, as we develop our businesses, we might sell or buy businesses or assets. In the event of a corporate sale, merger, reorganization, sale of assets, dissolution, or similar event, Your Data may be part of the transferred assets.
- Aggregated, De-Identified Information: We may use Your Data to create aggregate or statistical information that does not directly identify a specific person, and we may share that information with third parties. We may also share anonymous and aggregated reports and information on user demographics and industry patterns with third parties.

We are not in the business of selling Your Data to others, and we share Your Data only as described above.

#### **5. How We Protect Your Data**

We use physical, organizational, and technical safeguards that are designed to protect the integrity and security of Your Data from loss, misuse, and unauthorized access, disclosure,

alteration, or destruction. However, no security measures are perfect or impenetrable. We thus cannot guarantee the security of our databases, nor can we guarantee that Your Data will not be intercepted while being transmitted over the internet to and from us.

## **6. Your Choices**

You have choices regarding the personal information we obtain about you.

You can update your profile information on Discord as explained on that website and application.

If you no longer want to use our Services and have an account with us, you can delete your account on the Discord server.

If you have consented to location services through your browser's settings, please consult your browser's documentation regarding how to turn off location services. Note, however, that if you disable location services, you may not be able to use the full array of features and functionalities available through our Services.

You can manage your receipt of marketing and non-transactional communications by clicking on the "unsubscribe" link located on the bottom of any Garage marketing email. We will use commercially reasonable efforts to process such requests in a timely manner.

## **7. Do Not Track**

As discussed above, third parties such as advertising networks and analytics providers may collect information about your online activities over time and across different websites when you access or use the Services. Currently, various browsers offer a "Do Not Track" option, but there is no standard for commercial websites. At this time, we do not monitor, recognize, or honor any opt-out or do-not-track mechanisms, including general web browser "Do Not Track" settings and/or signals.

## **8. Children's Privacy**

We do not knowingly collect, maintain, or use personal information from children under 18 years of age, and no part of the Garage Services is directed to children under the age of 18. If you learn that your child has provided us with personal information without your consent, you may alert us at the contact information listed below. If we learn that we have collected any personal information from children under 18, we will promptly take steps to delete such information and terminate the child's account.

## **9. Notice to California Residents**

Pursuant to Section 1798.83 of the California Civil Code, residents of California have the right to obtain certain information about the types of personal information that companies with whom they have an established business relationship (and that are not otherwise exempt) have shared with third parties for direct marketing purposes during the preceding calendar year, including the

names and addresses of those third parties, and examples of the types of services or products marketed by those third parties. Please note, however, that we do not disclose Personal Data to third parties for such third parties' direct marketing purposes.

#### **10. Notice to Nevada Residents**

If you are a resident of Nevada, you have the right to opt-out of the sale of personal information to third parties. Please note, however, that we do not sell personal information.

#### **11. Notice to Non-US Residents**

The Website and Services are operated in the United States. If you are located outside of the United States, please be aware that any information you provide to us maybe transferred to, processed, maintained, and used on computers, servers, and systems located outside of your state, province, country, or other governmental jurisdiction where the privacy laws may not be as protective as those in your jurisdiction.

#### **12. Changes to this Privacy Policy**

We may update this Privacy Policy from time to time and without prior notice to you to reflect changes in our privacy practices. We will indicate at the top of this Privacy Policy the date that this Privacy Policy most recently updated, and we encourage you to revisit this page periodically to stay aware of any changes thereto. Your use of the Services after any changes to the Privacy Policy are posted means that you agree to all of these changes. The use of information we collect is subject to the Privacy Policy in effect at the time such information is collected.
